CAMPUS EATS LTD. VENDORS AGREEMENT

This CAMP	US EATS LTD VENDORS Agreement is entered into as

as follows:	

What is Campus Eats: CAMPUS EATS is a mobile application service that provides the platform for vendors primarily of food on campuses to vend as CE (Campus Eats) handles their deliveries over defined geographical areas.

WHO IS A VENDOR: A vendor represents a person that vends products on Campus Eats.



VENDOR ROLE:

- 1. The vendor is obligated to provide Campus Eats with highquality products from their inventory in order to generate revenue by reaching out to current and potential customers.
- 2. The vendor monitors sales performance and maintains adequate inventory levels for store orders.
- 3. The vendor is responsible for the advertisement of their product on Campus Eats.
- 4. The vendor is responsible for creating and maintaining their stores via the Campus Eats Vendor dashboard.
- 5. The vendor is responsible for creating and maintaining their products in stores through the Campus Eats Vendor dashboard.
- 6. The vendor is responsible for providing safe product for the consumption of users on Campus Eats.
- 7. The vendor is obligated to convey the product to the delivery personnel upon arrival of the delivery personnel indicating clear order details on their product package.
- 8. Vendors must under no circumstance use information provided them on their dashboard for personal use or any other aside Campus Eats operations.



OUR SERVICE TO VENDORS:

- 1. We affiliate your products on the Campus Eats platform. [Affiliate means we earn a commission by promoting or selling your product on our platform.]
- 2. A dashboard will be provided to vendors to help track inventory quota, product sales, and also well performing products.
- 3. Campus Eats is responsible for the delivery of products to customers.
- 4. Campus Eats charges with flexible and affordable delivery packages based on location and distance for the delivery of Product.
- 5. Campus Eats ensures the safety of your product within the duration of reception from vendor to delivery to customer.
- 6. Campus Eats provides vendors with a platform to sell their products and also maintains the platform.



MUTUAL AGREEMENT

- 1. Quality is our main priority, products that fail our quality check would be declined. Campus Eats operates on a strict quality check program, thus, we make sure products uploaded by Vendors are safe for consumption.
- 2. Stores that pass the quality check would be approved by Campus Eats and then moved to the platform for sales to begin.
- 3. Vendors must pay the agreed amount communicated by Campus Eats Team to sign up to Campus Eats Program.
- 4. Stores without orders in 30 days will be removed from the Campus Eats platform as well as its inventory. Vendors are to contact Campus Eats Team for their stores to be restored on the platform. This will attract a fee payment.
- 5. Vendors will receive payment within 24 hours after successful sale.
- 6. Percentages added to products are structured by Campus Eats. [Percentages added serves as commission]. Percentages appended will be communicated to vendors and as and when changes are made, vendors will be given a notice.
- 7. Vendors' profits are still 100%. [Campus Eats is only entitled to commissions added]
- 8. Vendors are to take care of product packaging themselves.
- 9. In any case the order is not completed as a result of customer not showing up for the product, product would be returned back to the vendor and order would be cancelled.
- 10. Vendors agree to terms and condition of Campus Eats platform. Find terms and conditions here https://www.campuseats.app/terms-and-conditions.
- 11. After three occasions of cases of food spoilage, vendor would be dismissed from selling on Campus Eats as contract is terminated with immediate effect.



- 12. Vendors are to note that their contact numbers are made available to customers. Campus Eats is hence not liable for further action of misconduct by customers. Such cases should however be reported to Campus Eats Team for further investigation.
- 13. In the case of complaints pertaining to food spoilage, customers are to be compensated by receiving a refund of the money paid for the product. Upon investigation and if found true, evidence would be sent to the vendor.
- 14. **Scope:** The purpose of this Agreement is to provide qualifying vendors with the opportunity to sell products through the Campus Eats platform. This Agreement supplements any other agreements governing the movements of products between Campus Eats and Vendor.
- 15. **E-Commerce:** For purposes of this Agreement, E-Commerce refers to the sale of products by Campus Eats to its retail customers via the Internet, Campus Eats websites, or any online system or computer network affiliated with Campus Eats. E-Commerce also includes any related business and marketing activities supporting such sales.
- 16. Vendors agree to the terms of service.

Terms: The Terms of this Agreement begins on the Effective Date and continues until either:

Campus Eats LTD. or Vendor terminate this Agreement upon seven (7) days written notice to the other. If terminated by either Party, the Agreement will continue to govern the sale of Vendor products purchased for E-Commerce prior to termination until such products are sold, returned, or removed from inventory so that no inventory of such product remains.



1. Representations and Warranties:

Vendors represent and warrant that:

- (1) Vendor has the power to authorize the sale and/or display of its products online and as part of Campus Eats operations.
- (2) All product information, data, images, and/or intellectual property provided by Vendors to Campus Eats for its E-Commerce business (a) complies with all applicable laws.
 - I. Authorizations: Vendors grants Campus Eats the non-exclusive, worldwide, royalty-free right and license to use and display any product information, specifications, warranty information, data, images, and/or intellectual property that Vendors provide to Campus Eats for use in its E-Commerce business during the Term of this Agreement ("Vendors Content"). Campus Eats may use Vendors' Content for any purpose related to its E-Commerce business or in furtherance of promoting Vendor's products, including use in Campus Eats platform, emails, and marketing or advertising campaigns. Vendors acknowledge that Campus Eats depend on Vendor honesty to ensure that all Vendors' Content is accurate and complete. Vendors agree to notify Campus Eats and revise and resubmit Vendors' Content promptly upon discovering that it is inaccurate or incomplete.
- (3) Campus Eats agrees that it will not make modifications or alterations to Vendor Content without Vendor's prior written approval.
- (4). Except for the limited license granted to Campus Eats herein, the Vendor retains all rights, titles, and interests to Vendor Content.
 - 1. Intellectual Property of Campus Eats: Vendors acknowledge



and agree that all patents, designs, trade names, trademarks, copyrights, trade secrets, or other intellectual property owned or controlled by Campus Eats shall be and remain the sole property of Campus Eats.
